### **PUBLIC COMMENTS:**

Don Bielefeld, Code Enforcement: Make sure to keep yard clean, take care of unregistered vehicles, and you can start to apply for snow plow permits.

Captain Norek, Police Department: Stats for August 2023, criminal complaints we had 105, non-criminal complaints 913 for a total of 1018 complaints. We had 22 property damage only accidents, 10 injury accidents, 3 bicycle accidents. We had 37 male arrests, 12 female arrests and 3 juvenile arrests. 71 parking tickets were issued and 330 traffic summonses were issued.

RJ Nieman, OEM: Reminder to sign up for the safety app – link can be found on OEM Facebook page.

Kevin Ferguson, Recreation: Rink is opening up on Sunday, compressor is in good shape, ice is all built up and staff will disinfect the locker rooms between groups.

Chief Gauthier, Fire Department: 17 calls so far for the month of September, 270 year to date. The annual inspection was held without the parade this year. Tomorrow is the boot drive, between 4 and 6:30pm, Hose Company #1 is having a meat raffle on Saturday, September 30<sup>th</sup> at St. Mary's High School, doors open at 6 and Cayuga Hose Company will be having a chicken bbq on October 14<sup>th</sup>, from 11am until sold out. Lastly, it's September 11<sup>th</sup>, lets not forget those who lost their life on this day 22 years ago.

Deputy Mayor Adolf: Wanted to thank the Chief and whole Fire Department for hosting the inspection.

Mayor Peterson: So some of the things from the inspection the other day, the number of hours that the members have put in from the six companies it was well over three thousand if I remember right and that's just a lot of training hours and very commendable to see that and you could also pick up a live broadcast of that on our on our Fire Department Facebook page I believe so where it is I saw it there.

Paul Sprada, 58 Argus: Just wanted to remind everyone it is the 22 anniversary of 9/11. And question about e-bikes and scooters whether they need to be licensed.
